

Next Meeting





If you want to go green but can't make or afford a wooden compost bin, Blue Peter have come up with an inexpensive and simple-to-make alternative. You will need:-

- 4 5ft or 1.5 metres canes
- 1 2 yards or 2 metres of rigid green plastic mesh
- 1 length of string

Make the mesh into a cylindrical shape, overlapping by about 2 inches



or 5 cm and secure with string at the top, middle and bottom and insert four canes between the mesh. Drive the canes into the ground to form the compost container. Start the compost heap with a thick layer of newspaper around the sides and fill with grass and plant cuttings. Carry on topping-up the heap with more plant refuse and vegetable waste from the kitchen.

Tax Planning

The tax planning opportunities at the end of the tax year on 5 April 1997 are this year heightened by the anticipated change in government on 1 May 1997.

Mortgages

If you are having difficulty obtaining a mortgage to move house, we may be able to obtain non-status mortgages through our independent Financial Advisor Christopher Bacon of Alton Associates (regulated by FIMBRA).

Investments

PEPs/TESSAs

Spare cash can be invested long term (at least 5 years) in a PEP (Personal Equity Plan) or TESSA (Tax Exempt Special Savings Account) with exemption from income tax and capital gains tax. You can invest each year:-

£6,000 in a general PEP & £3,000 in a single company PEP.

You can make a £3,000 initial investment and £1,800 annual investment, up to a maximum of £9,000 in a TESSA.

Pensions

If you wish to carry back pension tax relief to 1995/96, the deadline for payment of the premium is 5 April 1997. Please allow a few days for the post and because 5 April is a Saturday in 1997.

Inheritance Tax

If you are considering gifts, the annual exemption can be used of £3,000 per annum and £250 small gift exemption. A Labour government may reintroduce a lifetime tax to replace the current PET regime so inheritance tax planning should be considered now.

Capital Gains Tax

Gains are exempt up to £6,300 in the year ended 5 April 1997 but the annual exemption must be used by 5 April for gains in 1996/97. An individual's annual exemption is £6,500 for 1997/98.

CONSTRUCTION INDUSTRY

The Inland Revenue are imposing a stricter interpretation of self employment on workers in the construction industry as from 6 April 1997. The rules for determining whether a worker is self employed or employed will particularly affect labour only subcontractors, even though they are working short term or on a casual basis for more than one employer.

The tests for deciding if a worker is employed are set out in the Inland Revenue's booklet which differentiates the degree of control and responsibility a person has over equipment and how the work is costed and done.

The disadvantages of employment are the increased taxes and administration regulations with which an employer must comply. An employer will need to account under PAYE for the employee's tax and national insurance deducted from gross plus the employer's insurance contribution of up to 10% of gross earnings. The employee will usually be unable to claim as many expenses under the stricter Schedule E rules which will increase their tax and national insurance payable to the Inland Revenue.

The consequences of making the wrong decision about a worker's tax status is that the employer could be liable to tax and NIC retrospectively as from 6 April 1997 if there is evidence of evasion. It is important to review the employment status of your own sub-contractors so action can be taken where possible to reduce the impact of these rules on your business.

Self Assessment

The Inland Revenue have issued new forms and changed procedures without a lot of warning to either accountants or to Inland Revenue staff, but we expect the system to become clearer from the new tax year.

1997 Tax Return

The new self assessment forms should arrive from 6 April 1997, but do not require to be filed until 31 January 1998 when automatic penalties will apply to late returns. We already have our new software in place to prepare tax returns on our computer system for electronic filing with the Inland Revenue in due course.

Tax Planning

There is scope to consider a change of accounting date closer to 5 April to minimise taxation of large profits under the transitional provisions. This change is subject to anti-avoidance provisions, tighter administrative deadlines and cashflow disadvantages if profits are rising.

Payments on Account

A claim to the Inland Revenue to reduce payments on account for 1996/97 can be made up to January 1998. Interest and penalties may arise where the claim is not valid. If your tax payable for 1995/96 is less than £500 the Inland Revenue will not seek payments on account for 1996/97 until 31 January 1998.

Record Keeping

The new rules for record keeping under self assessment are already in effect. There is an obligation under tax law to keep satisfactory records for at least 12 months (personal) and at least 5 years (business) after the tax year's last filing date of 31 January.

Employers

Employers will need to provide more information to staff. There will be new deadlines for supplying employees and the Inland Revenue with information from 6 April 1997 for the 1996/97 tax year:-

19 May	Forms P35/P14 and SC35 must be submitted to the Inland Revenue.
31 May	Form P60 must be given to employees.
6 July	Form P11D must be submitted to the
	Inland Revenue and the same information provided to the employee.

Penalties will be automatic for late or incorrect returns. There will be a maximum penalty of £3,000 for incorrect forms P11D and P60 and initial penalties of £300 per form and up to £60 per day for continuing failure to provide forms P11D.

Business Miles

Directors and higher paid employees who wish to reduce their car benefits should ensure documentation is available to claim either 2,500 business miles or 18,000 business miles.
